Name/Logo/FEIN Use Policy

Dated: April 25, 2013

The MB Sand & Surf, Inc. name, FEIN (IRS Tax ID#), and logo (collectively, "Product") are the property of MB Sand & Surf, Inc. ("MBSS"). MBSS believes it is important to protect the use of the Product so they are used only in a manner pre-approved by the MBSS Board of Directors. All use must comply with the mission, philosophy, and policies of MBSS.

Use of the Product shall be only with the prior written permission from the Board of Directors. The Board of Directors may withhold approval at its sole discretion. The Board of Directors reserves the right, in its sole discretion, to (i) terminate permission previously granted at any time; (ii) modify permission previously granted at any time; and (iii) waive any of the use guidelines set forth below. The failure to abide by these use restrictions may result in player/team suspension, expulsion prosecution.

Use Guidelines:

- The Product must be used only for the purpose requested and as outlined in the completed and approved Request and Agreement For Name/Logo/FEIN Use form. A separate form must be completed and approved for any additional or ancillary use(s).
- The Product may not be used in any manner that expresses or might imply MBSS' affiliation, sponsorship, endorsement, certification of approval of any product or service.
- Except as provided herein, you may not alter the logo in any manner, including size, proportions, colors, elements, or animate, morph or otherwise distort its perspective or appearance. However, the logo may be resized to accommodate a specific use, but the text within the logo must remain legible.
- The logo may not be altered to incorporate any other object, including, but not limited to other logos, icons, words, graphics, photos, slogans, numbers, design features, symbols, audio files or video files.
- The FEIN number may not be used in connection with team specific sponsored fundraising.
- The term of any granted use shall automatically expire the week before tryouts for the applicable team, unless a shorter duration is designated on the approval form by the Board of Directors.

In order to use the Product, teams must complete the following steps:

1. Download and complete the Request and Agreement for Product Use form found at www.mbsandandsurf.com.
2. Email the completed form to the Club Administrator (finmgr@mbsandandsurf.com).

3. The Club Administrator will submit the request to the Board of Directors. The Board of Directors may require the applicant to appear at the next board meeting to discuss the request.
4. The Club Administrator will send a copy of the form back to the applicant marked either "Request Approved" or "Request Denied", and will keep a copy of the form in the club's files.
